Proposed bylaw or policy section and language:

9.22 State A & B Schedule (10/09/2016)

Any city/team that builds a new pool (which meeting minimum Championship Meet Requirements, Exhibit 1) will, starting the season immediately following opening (not the season of opening), host the State B Championship Meet, then host the State A Championship Meet the year after, with a new rotation being established.

- (1) Any team in a City that does **not** meet the minimum Championship Requirements in Exhibit 1 has the opportunity to "host" the State Championship Meet (B or A) in accordance with the rotation laid out in Exhibit 2 at a facility that meets the minimum Championship Requirements (again in Exhibit 1).
 - (a) The "home team" would be entitled to a flat fee (or defined % of revenue from the meet) for their assistance with the scoreboard, meet marshals and other technical/planning details in dealing with a City owned facility. This fee or percentage would be preset at the annual fall meeting.
- (2) Whenever a team cannot host a meet as scheduled, the meet is open for bids. (09/23/2012)

Exhibit 1:

Minimum Requirements for a State Championship Meet (Short Course):

1. 8 lanes 25 yards available for competition
2. Spectator availability for a minimum of 250

Minimum Requirements for a State Championship Meet (Long Course)

1. 8 lanes of 50 meters available for competition
2. Ability to dive in from either side of the pool

(4) Travel Funds – South Dakota Swimming, Inc. shall budget money for the Central Zone Championships. The amount should include \$50 per session for each of 3-4 coaches selected by the LSC, a reasonable sum for coaches' travel and food, and a reasonable sum for zone caps and t-shirts. If possible, there should be some amount budgeted to defray travel and/or lodging expenses of athletes, coaches and chaperones.

(4) Travel Funds – South Dakota Swimming, Inc. shall budget money for the Central Zone Championships. The budgeted amount should include a reasonable sum for zone caps and apparel. If possible, there should be some amount budgeted to defray travel and/or lodging expenses of athletes, coaches (3-4 selected by the LSC) and chaperones.

(4)(a) Coach Reimbursement - The budgeted amount should include the items below. For years Mega Zones are held, reasonable adjustments to amounts should be made for further travel and longer sessions.

Coaches will be paid:

- \$75 for each zone team practice coached prior to the meet
- \$75 for the coach preparing/submitting the apparel order
- \$100 for the head coach for pre-meet prep work (receiving/reviewing athlete applications, answering emails)
- \$100 for the coach in charge of trip planning (rooming assignments, itinerary, finding chaperones)
- \$75 for each coach preparing meet entries
- \$75 for time traveling to/from the meet.
- \$75 per session coached (Thursday team practice, prelims, 10 & Under, and finals are separate sessions)
- Reimbursement for reasonable food and mileage at the current rate.

Rationale:

Coach pay for Central Zone Championship meet has not increased since at least 2007. Under the current rule, coaches do not receive compensation for practices held before the meet, time traveling to/from the meet, preparing/submitting meet entries, trip planning, or preparing/submitting the apparel order, all of which are time consuming duties.

(1) Each coach will receive \$75 per session worked, including the Friday practice. Assistant coaches preparing meet entries will receive \$75 with the head coach receiving \$100 with the additional duty of submitting all entries. The coach preparing/submitting the apparel order will receive \$75.

(2) Each coach will receive reimbursement for reasonable food and hotel expenses, and mileage at the current rate. Each coach will also receive \$75 for time traveling to/from the meet.

Rationale:

Coach pay for All-Stars has not increased since at least 2007. Under the current rule, coaches do not receive compensation for time traveling to/from the meet, preparing/submitting meet entries, and preparing/submitting the apparel order, all of which are time consuming duties.

Proposed bylaw or policy section and language:

I'm proposing we create a SD Swimming Select Camp. Similar in structure to how USA Swimming runs their select camps. Swimmers 11 & up will be invited to attend based on their IMX scores.

Who: Ages 11-18, 36 swimmers

Selection Process:

Swimmers with the top LCM IMX Score from the previous LC season from each of the following age groups:

Top 5 boys from each of the 11-12, 13-14 age groups

Top 5 girls from each of the 11-12, 13-14 age groups

Top 8 boys from the 15-18 age group

Top 8 girls from the 15-18 age group

Athletes' age is determined as of September 1st, 2017.

What: A 2.5 day camp that brings the best age group swimmers from around the state together to educate, train, and get to know other swimmers.

Why: To bring together our age group swimmers that excel at a young age and help develop them into elite level senior swimmers, while also fostering relationships with swimmers from around the LSC.

Where: Sioux Falls, Midco Aquatic Center

When: October/November of 2017, specific dates still to come

The head coach would be from outside the LSC to run the camp for the kids with 3 assistant coaches from SD Swimming to help run the camp as well. USA Swimming would most likely also send a representative to help with some of the talks and be there for the weekend. Also planning on some parent education sessions.

I'm asking the LSC to approve the tentative budget and funding for this camp.

Rationale:

I think this would benefit our swimmers as they are growing in the sport and looking at what is next for them. This would be a chance to get together with kids from other teams and train together, an opportunity a lot of kids don't get being on small teams. Bringing in an outside coach would also give them a different coaching perspective and experience than what they are used to. Using their IMX scores helps promote a USA Swimming program that focuses on versatility and is how USA Swimming selects a lot of their higher level camps and teams. With SD Swimming promoting that as well hopefully more of our kids would be recognized on a Zone level.

This is also the first step I see in developing a bigger camp program for our LSC. USA Swimming will provide up to 4 different camps each year, for all abilities and ages that we could offer for our swimmers.
